- D. Information Booth at Fall Antiques Street Fair

- E. Discussion on next project
The Town Clerk shared that would be a good idea for the HPC to send a letter to the owner of the Historic Jail and inquire about purchasing the jail and moving to Town owned property where it could be used for a museum as it was originally intended, sharing with current owner that the intent is to continue to improve maintenance and preserve historic structures. The Town Clerk noted she frequently receives calls from people wanting to tour the jail. Kay Kelly shared some history behind the jail.
- F. Local Landmarking
Discussion of local landmarking on 121 Carthage St and 1780 NC HWY 24-27 both have expressed interest in becoming a local landmark.

Other Topics:

Sandy Leiby expressed interest in a historic property demo by neglect, what are our capabilities of trying to get the owners to do something to fix them and not let the properties gradually fall in.


